

The impact of the COVID-19 epidemic on healthcare workers – June 10, 2020 Nicaragua, June 16, 2020

In the Citizen Observatory's last report (June 10, 2020), we reported a total of **536 suspected cases of COVID-19 among healthcare workers** and **61 casualties** due to pneumonia or suspected COVID-19. Below we present an analysis of the data from the Observatory on suspected cases of COVID-19 among health care workers in last four weeks.

The previous analysis indicates:

- 1 out of every 10 cases verified as suspected COVID-19 by the Citizen Observatory corresponds to healthcare workers. (*)
- 6 out of every 100 cases verified as suspected COVID-19 by the Citizen Observatory corresponds to doctors. (**)
- 6 out of every 10 cases of suspected Covid-19 in healthcare personnel corresponds to doctors. (**)

We remind people to continue taking precautionary measures: washing their hands for forty seconds, keeping to a distance of at least two meters, wearing a mask in public, staying home or only going out if is necessary.



Below we have presented an analysis of data from the Citizen Observatory on **deaths of** healthcare workers from presumed COVID-19 over the last four weeks.

The previous analysis indicates that in the last two weeks:

- 1 out of every 10 cases of suspected COVID-19 in healthcare workers reported by the Citizen Observatory has resulted in death. (*)
- 4 out of every 100 deaths reported by the Citizen Observatory corresponds to healthcare personnel.

The Observatory collects data on COVID-19 related symptoms and deaths among healthcare workers. We do not gather information on other impacts, for example on mental health, as a result of long working hours, being isolated from family, being aware of the potential risk for infecting family and being in contact with the disease without appropriate protection. Each healthcare worker who becomes sick means there is less capacity to treat patients who need healthcare. It also generates mistrust in the system's capacity to respond to demand. Each death is an irreparable loss. It is inadmissible and irresponsible that the government is not providing appropriate personal protective equipment to the healthcare workers that are caring for the population, and arbitrarily firing personnel who are needed on the frontline. It is necessary that the government takes measures to protect healthcare workers instead of continuing to intimidate, threaten or sack them.

We demand:

- That the necessary quantity and quality of appropriate personal protective equipment is provided to all healthcare workers that are involved in treating COVID-19 patients.
- That more healthcare workers are hired to adequately respond to demand in the first instance, particularly in hospitals.
- That the threats, harassment and arbitrary sackings of healthcare workers are halted.
- That arbitrarily sacked healthcare workers are reintegrated to their jobs.

If you can, stay home and save lives!
